

## Rules & Regulations

### Capital 96.3 Block Party

No purchase necessary. To enter visit [www.capital963.com](http://www.capital963.com) and fill out the contest entry form under Block Party in the contest section of the site with your name, address, phone number. Please note that entrant must be the home owner of location; cannot be a rental property.

The Contest is open to all residents of Edmonton and area, eighteen (18) years of age or older, excluding residents of Quebec, employees of CAPITAL 96.3, New Cap Radio, its parent company, affiliated companies, advertising and promotional agencies, participating sponsors and any persons residing in their respective households.

CAPITAL 96.3 will host 6 Block Party Outs between May 26 & August 25, 2017.

Each Block Party will consist of:

- One Block Party Party, hosted in winner's front or back-yard on pre-determined date
- CAPITAL 96.3 will provide food and beverages for up to 40 people from The Cheese Cake Café and Big Rock Brewery, and a LIVE Band from the Rock N Roll Society of Edmonton (food to be determined by Cheese Cake Café prior to designated Block Party dates). In addition, Block Party winners will also receive a \$500 gift voucher from Green Drop
- All Block Party winners will also be entered to win a Lennox 13ACX (any size) complete with coil, line set, drain line, electrical work, permit, brackets or pad, AC cover, Honeywell pro6000 thermostat and first year's maintenance from Romaniuk Heating & Air Conditioning at the end of the promotion.
- Winner to provide additional food and beverages for guests
- Winner to provide space for the band to play at event (rain or shine). If winner cannot provide shelter, in the case of rain, the band will not play at selected Block Party
